1 Definitions and Interpretation

2 Variation

- 2.1 CRC and the Research Provider agree that in accordance with clause 21.9 of Annexure D of the Research Agreement, from the date of this Deed the Research Agreement is varied as follows:
 - a) Annexure A of this Deed has been amended to reflect new co-contributions for project [project number and name]

b) Annexure B of the Research Agreement has been amended to include the new Project Plan for project *[project number and name]*

These changes are reflected in Annexure B to this Deed, which replaces Annexure B to the Research Agreement dated *[date]*.

3 General

- 3.1 This Deed takes effect on and from the date stated on page 2.
- 3.2 CRC and the Research Provider affirm the Research Agreement and agree to continue to be bound by its terms which, apart from the amendment expressly set out in Part 2 of this Deed, will remain in full force and effect and unchanged in all other respects. With effect from the date of this Deed, the Research Agreement as amended by this Deed is to be read as a single integrated document incorporating the amendments affected by this Deed.
- 3.3 This Deed together with the Research Agreement is the entire agreement and understanding between the parties on everything connected with the subject matter of this Deed; and supersedes any prior deeds, agreement or understanding on anything connected with that subject matter.
- 3.4 This Deed may be executed in any number of counterparts. A counterpart may be a facsimile or an electronic copy. Together all counterparts make up one (1) document.
- 3.5 If this Deed is executed in counterparts, it takes effect when each party has received the counterpart by the other party or would be deemed to have received the counterpart.
- 3.6 Each party must pay its own costs and outlays connected with the negotiation, preparation and execution of this Deed.
- 3.7 This Deed shall be governed by and construed in accordance with the law for the time being in force in the State of Queensland and the parties hereby submit to the jurisdiction of the Courts of that State.
