4 Reports

4.1 Chair's report

The Chair's report was circulated with the AGM meeting papers and taken as read.

The Chair highlighted the following points regarding the 2021/22 year.

- The year has seen a reinvigorated CRCNA emerge as key player in the Northern Australian development agenda driving a refreshed approach through our commitments to larger projects and new programs of work which will enable the economic development of Northern Australia in years to come. This year we added another **18 new projects**, bringing our investments to 75 projects overall.
- We have reinforced our relationship across the three northern jurisdictions Western Australian, Northern Territory and Queensland governments – with funding contracts for co-designed projects with the CRCNA.

She outlined some of the projects that are creating real industry jobs including:



- Tropical Rock Lobster industry in Northern Australia through Ornatas
- Investments in native bush foods particularly Kakadu Plum
- Forestry project on Tiwi Island

and projects that are moving from field trials to commercial contracts

- Project partner AgriVentis secured a commercial contract to supply kalonji (nigella) seeds to Melbourne-based seed processing company Hab Shifa with the view of replacing their import contracts.
- The team at the Darwin Aquaculture Centre launched the world's first hatchery protocol manual for the Blacklip Rock Oyster which was formally added to the Australian fish name database in February 2022.
- In the health area we have focused on health service delivery and early detection

She noted that a more detailed overview of these projects and others are available in the Annual Report now downloadable from our website crcna.com.au.

Looking forward, the Chair acknowledged that the CRCNA has reached its halfway mark in its funding contract with the Australian Government. With all Grant funds now committed and as more projects come to an end CRCNA's focus will be firmly on ensuring that this work is translated and used by industry and the community.

She also noted that over the next 18 - 24 months the CRCNA will undertake a comprehensive evaluation of our projects past and present, to better understand their impact and identify the future opportunities.

The Chair noted recent changes to the Board and thanked the Directors and management for their commitment to achieving so much this year and their ongoing professionalism. She made special mention of John Bearne who has served on the Board of Directors and as Chair of the Finance and Audit Committee for 5 years but is choosing to step and down and pursue other endeavors.

She concluded commenting that she looks forward to the opportunity to contribute to the refresh of the Northern Australian agenda – a commitment recently announced at the Ministerial Forum in Darwin last week. The CRCNA is strongly positioned to continue to inform and influence this agenda.

4.2 CEO's report

The CEO's report was circulated with the AGM meeting papers and taken as read.

The CEO thanked the Chair and Board for their support and recognised the commitment of the staff over the past 12 months.

4.3 Appointment of auditor

John Bearne advised that Crowe Audit Australia were the auditors for the 2021/22 year and that the Board recommended to the Members their reappointment.

6. Appointment of Directors

He concluded by congratulating Sheriden on her reappointment and welcoming Scott to the Board.
